1.0. Welcome and Call to Order

The meeting was held in person and via GoToMeeting. David Brazil called the meeting to order at 10:01am.

1.1. Introduction of New Representatives

David Brazil introduced three new Committee representatives. Whitney Zerr will represent Hoxie Medical Clinic, replacing Pam Popp. Two health centers joined the HCCN in August. Dr. John Mandeville will represent Sharon Lee Family Health Care and Brandi Finocchario will represent Vibrant Health on the Committee.

2.0. HCCN Program Director Report

2.1. 16-010 Project

The final project status report for this project was included in the meeting binder. Terri Kennedy, Program Director, highlighted the following items.

- Final 3-Year Targets: The HCCN was meeting 5 of the 10 grant targets and the end of the grant project. Performance improved in 7 of the focus areas and declined in only 1, Advance Meaningful Use.
- Final Targets Met by PHCs: Hoxie Medical Clinic finished the project meeting 9 of the 10 grant targets. Eight health centers met 8 grant targets – Atchison CHC, CHC in Cowley County, First Care Clinic, GraceMed Health Clinic, Heartland CHC, Konza Prairie CH&DC, PrairieStar Health Center and Salina Family Healthcare Center. Genesis Family Health, Health Ministries Clinic, Health Partnership Clinic, HealthCore Clinic, Heart of Kansas Family Health Care and Hunter Health each met 7 grant targets.

2.2. 19-011 Project

The initial project status report for this project was included in the meeting binder. Terri Kennedy, Program Director, highlighted the following items and provided a brief overview of the grant goals and objectives.

- 3-Year Targets: The HCCN started the grant not meeting any of the 9 grant targets.
- Targets Met by PHCs: First Care Clinic began the grant project meeting 5 targets. Genesis Family Health and Health Partnership Clinic are meeting 4 targets.

3.1. Final Evaluation Report

The final evaluation report for the 16-010 project was included in the packet. Consultant Susan Leonard conducted interviews and a survey to gather information to complete the report. Overall, the report was positive and provided recommendations in three areas.
