- Three projects are included in the report
- HCCN Project (ended in July)
  - The HCCN ended the project meeting or exceeding 6, 3-year targets!
- American Rescue Plan (Active through March 2023)
  - COVID-19 SDOH Assessment - 9 PHC interviews completed and PHC proposal shared with NACHC.
  - Expanding Data Capacity – new data system design in progress.
  - VBC Learning Collaborative - in-person meeting held in July.
- New HCCN grant cycle (started in August)
  - 10 objectives and targets (no goals).
  - Potential changes to 3 work plan activities.

### 4.0. New Business

- Project Evaluation - Performed by Susan Wilson and Lynda Meade.
  - Four objectives received lower ratings at the end of the project than the mid-term evaluation (approximately 1.5 years ago). A discussion of why this may have occurred followed.
    1. Staff completing it may be different (Jonathan at Atchison). Rhiannon had the same thought.
  - Shared plans to improve the monthly status meetings to discuss progress toward goals.
- HRSA released UDS CHQR awards for 2021 UDS data; the HCCN's CQMs are aligned with these goals.
